Just prior to the visit the site had received a 0,5+ inch of rain. There was no visible free phase product or sheen observed in all three Divisions and there was a lot of emerging vegetation observed in Division A and Division C. Per the recommendations and observations made during “UC” visit on 10/3/2014, 'Plains' request concurrence that the goals of the IAP and O&M plan had been met and that “no further action” be required at the site known as “Plains at Stevens Facility Oil Spill”, with these exceptions:

(1) 'Plains' will maintain the Oil Shark® Fence and perform inspections after storm events that produce >0.5 inches of rain in a 24 hour period until 10/17/2014; and,

(2) John Mark Henderson, MDEQ Haz Mat SOSC-R, will set up a time in the spring 2015 to look over Division C to evaluate vegetative growth.

The UC agreed that the pom-pom type adsorbents can be removed now, but the Oil Shark® Fence and boom will remain intact until 10/17/2017, at which time all the components may be removed...
