DESCRIPTION OF INCIDENT

CALLER IS REPORTING A DISCHARGE OF UNKNOWN AMOUNT OF ETHYLENE AND DIESEL FUEL ONTO THE GROUND AND INTO THE SANTIAM RIVER AT THE INCIDENT LOCATION. DISCHARGE IS FROM A TANK TRUCK THAT WAS INVOLVED IN A SINGLE VEHICLE INCIDENT, DUE TO UNKNOWN CAUSES. INJURIES ARE REPORTED BUT UNKNOWN THEIR CONDITION AND HOW MANY.

CALLER STATED THE SANTIAM RIVER IMPACTS DRINKING WATER IN THE NEARBY AREAS AND THERE IS APPROXIMATELY 10,000 GALLONS OF CARGO ON BOARD BETWEEN THE DIESEL FUEL AND ETHYLENE.
