

RECORDING RELEASE OF OPTION

KNOW ALL MEN BY THESE PRESENTS:

That Petrotomics Company, a co-partnership, has heretofore released and relinquished unto Kerr-McGee Corporation all rights to acquire those certain mining claims, leases and fee lands described in the Schedule A hereto attached, and has heretofore released and relinquished unto Tidewater Oil Company, Getty Oil Company (who has since succeeded by merger to the interests of Tidewater Oil Company) and Skelly Oil Company, as tenants in common as to an undivided 1/3 interest each, all rights to acquire those certain mining claims and leases described in Schedule B hereto attached, (the aforesaid claims, leases and fee lands being herein called the "Subject Properties") under and pursuant to the option granted it by virtue of Article IX of the below identified "Partnership Agreement"; hereby agreeing that Petrotomics Company (i) has released said option insofar as the said Subject Properties are concerned and all interest whatsoever of Petrotomics Company in and to the Subject Properties and (ii) has discharged and removed the Subject Properties from the Exhibit B and Exhibit D to said Partnership Agreement, leaving them entirely free and clear of and from the provisions of the Partnership Agreement, and (iii) has deleted the lands covered by the Subject Properties from the "Area of Interest" created under the provisions of such Partnership Agreement, all with the same force and effect as though none of the Subject Properties had ever been listed on said Exhibit B or Exhibit D or been included within the "Area of Interest".

The "Partnership Agreement" herein referred to is that certain Partnership Agreement, dated July 23, 1960, entered into by and between Tidewater Oil Company, Getty Oil Company (successor by merger to the interests of Tidewater Oil Company, effective as of September 30, 1967) and Skelly Oil Company, as Parties of the First Part, and Kerr-McGee Oil Industries, Inc. (now known as Kerr-McGee Corporation), as Party of the Second Part, as such Partnership Agreement has from time to time been amended.

EXECUTED this 2nd day of November, 1967, for and on behalf of Petrotomics Company, a co-partnership, by the Partners therein, each of whom confirms its agreement with and to the foregoing.

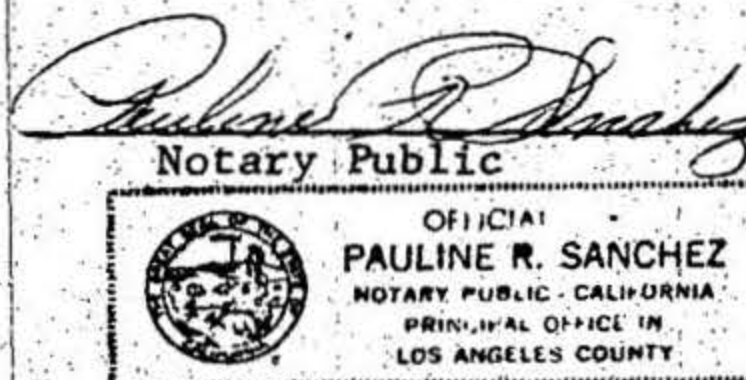
