**MEMORANDUM**

SUBJECT: Maintenance for Factory Street

In accordance with Chapter 14, Article 32 of the Revised Charter of the City and County of Honolulu, as amended ("ROH"), we wish to discontinue maintenance of Factory Street from King Street to Stanley Street.

The Department of Facility Maintenance (the "Department") has recently identified non-compliance to Chapter 14, Article 32, Section 14-32.2(a)(3) that requires that "[t]he street or road is open to, serves, and benefits the general public"; Chapter 14, Article 32, Section 14-32.2(a)(4) that requires that "[t]he street or road is not signed, marked, delineated, fenced, barricaded, or otherwise designed, constructed or operated to exclude access by the general public, in whole or in part, which may be through such means as signs indicating that the street or road is a "private" street or road, or any restrictions on parking which are not applicable to all persons except as otherwise provided by law." The Department recently identified numerous "Authorized Parking Only" signs along Factory Street.

The Department has issued written notice dated December 21, 2016, to all property owners on Factory Street from King Street to Stanley Street of non-compliance to ROH. Signs were removed, but later re-installed.

In accordance with Chapter 14, Article 32 of the Revised Charter of the City and County of Honolulu, as amended ("ROH"), we wish to discontinue maintenance of Factory Street.
